



# Wave 1 Changes between V6.1 and V7.0.0

This document highlights the final numbers for Wave 1 V7.0.0 compared to Wave 1 V6.1 (previous public release dataset) and also documents some useful information for users and major changes in variable names.

# i) Change in numbers between releases

The below table shows the number of individuals and households in each data file.

## ii) New variables and useful information

## 1. "Other (specify)" questions

NIDS had previously chosen not to release any of the answers to the "Other (specify)" questions for Wave 1. The variables containing these answers end with the suffix "\_o". These have since been reviewed and added to the Wave 1 dataset. During the review process some of the answers which initially fell under "Other (specify)" have been re-categorized into already existing categories.

#### 2. Interview outcome

In previous releases, no household or individual interview outcome variables existed in the Wave 1 dataset. An outcome variable has since been added to the Adult, Child, Household Questionnaire and Proxy data files in order to be consistent with other waves. The variable is  $w1_Y_outcome$  (where Y represents the relevant data file).

### 3. Weights

Changes have been made to the design of the weights. Please refer to the draft technical paper Branson, N & Wittenberg, M (2018). Longitudinal and Cross sectional Weights in the NIDS data 1-5. NIDS Technical Paper 8 for further information about the weights. We don't anticipate that these changes will result in substantive changes to your analysis, therefore if anything seems incorrect or strange, please let us know. Given these changes, please ensure that you use the complete suite of data in the 2018: Version 1 release (i.e. do not use data files from an older NIDS data release together with some of the Release 2018: Version 1 data files).
